

**ARTICLES OF INCORPORATION
OF
PHILIPPINE INSTITUTE OF ENVIRONMENTAL PLANNERS**

Know All Men By These Presents:

The undersigned incorporators, all of legal age and a majority of whom are residents of the Philippines, have this day voluntarily agreed to form a non-stock corporation under the laws of the Republic of the Philippines.

And We Hereby Certify:

First: That the name of the said association shall be:

Philippine Institute of Environmental Planners

Second: That the purpose or purposes for which such corporation is incorporated are:

To advance at all levels the study of national, regional and urban planning encompassed in the term Environmental Planning; To promote the comprehensive physical, economic, social and aesthetic development of the different regions, cities, and municipalities and to encourage their balanced development.

To raise, protect, and advance the interest of the profession of environmental planning and the professional status of environmental planners, to promote and organize national and international conferences, seminars, and meetings to take steps for the examination and registration of professional, and regulation of the practice of environmental planning; and to formulate and adopt a Code of Professional Practice and Conduct of Environmental Planners.

To establish by purchase, donation or other means a library of books, maps, plans, drawings, and other documents and models and to ensure the maintenance, expansion and improvements thereof.

To study and bring to the attention of the governmental authorities and private entities and the officials thereof and to the people at large matters affecting environmental planning for appropriate action.

Third: That the principal office of the association is located in the City/Municipality of Quezon City, Philippines.

Fourth: That the term for which the said association is to exist is fifty (50) years from and after the date of incorporation.
